“Associate” **members shall be employees of the Corporation. Associate members shall be entitled to attend but shall not be entitled to vote at any meeting of the Corporation.**

Membership year is from January 1 - December 31. Cost of membership is \$1.00 / calendar year.

I agree to abide by and sign the Indian Youth Friendship Society’s “Code of Ethics” (see attached) or other terms and conditions as set out from time to time by the Board of Directors.

I agree to abide by and sign the Indian Youth Friendship Society’s “Oath of Confidentiality” as attached.

Qualifications to Become a Director

- Must have paid the required membership fees
- Must supply a “Declaration of No Undischarged Bankrupt”
 - Must agree to be bound by the “Code of Ethics”
 - Must agree to sign the “Oath of Confidentiality”
- Must be a full member of the Corporation or shall become a full member within ten (10) days after election or appointment as a director
- Must supply a current CPIC including a vulnerable sector search that is satisfactory within three months of being elected / re-elected or appointed to the board

- Members must have paid all dues or fees thirty (30) days prior to the date of the meeting

CODE OF ETHICS

5. As a member of the Indian Youth Friendship Society, I will at all times conduct myself in a manner that brings respect and credibility to the Indian Youth Friendship Society.
6. As a member of the Thunder Bay Indigenous Friendship Centre, at no time will I say or do anything that might appear to discredit the Thunder Bay Indigenous Friendship Centre.
7. As a member of the Thunder Bay Indigenous Friendship Centre, I will assume the responsibility to bring forward, in accordance with the Thunder Bay Indigenous Friendship Centre's policies and procedures, any grievance, comment or criticism that I may have.
8. As a member of the Thunder Bay Indigenous Friendship Centre, I will be responsible to work co-operatively with fellow citizens toward a human society equal opportunity for participation, tolerance of differences and respect of all living things.
9. As a member of the Thunder Bay Indigenous Friendship Centre, I will endeavour to work co-operatively with other groups, organizations or individuals (both Indigenous and non-Indigenous) to solve problems and to support mutual concerns.
10. As a member of the Thunder Bay Indigenous Friendship Centre, I will work to promote the well -being and the livelihood of the Indigenous community.
11. As a member of the Thunder Bay Indigenous Friendship Centre, I will promote the cultural, educational, economic and community development within the Indigenous community.
